1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 3. **How to Enter.** To enter:

On-Air: Listen to the Station on Thursday April 11, 2018 in the afternoon between 3 p.m. and 5 p.m. When the Station plays the õcue-to-callö sounder, listeners should call the Station at 814-866-1023. Caller twelve (12) to the Station, as determined by the Station in its sole discretion, will win. Time Delay between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Stationøs analog over-the-air signal and the Stationøs online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Stationøs analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished..

- 4. **Winner Selection.** The Twelfth (12th) caller, as described above, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call.
