The Station will conduct the Z102.3 **SUNVIEW GOLFSWEET DEAL CERTIFICATE GIVEAWAY** (the õContestö) substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. On-Air: Listen to the Station on Thursday June 13, 2019 in the afternoon between 3 p.m. and 5 p.m. When the Station plays the õcue-to-callö sounder, listeners should call the Station at 814-866-1023. Caller twelve (12) to the Station, as determined by the Station in its sole discretion, will win. Time Delay between Over-the-Air Analog Signal and Internet Broadcast: Due to the time delay that exists between the Stationøs analog over-the-air signal and the Stationøs online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Stationøs analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished..

- 4. **Winner Selection.** The Twelfth (12<sup>th</sup>) caller, as described above, may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Caller will be notified at the time of his/her call. Station decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest
