## Z1023 BRIT FLOYD 5-4-3-2-1 TICKET GIVEAWAY CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WQHZ (õStationö), owned and operated by Cumulus Media Holdings Inc. or one of its subsidiary companies, 471 Robison Road, Erie, PA 16509, during normal business hours Monday through Friday or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the Z1023 "Brit Floyd 5-4-3-2-1-Ticket Giveaway" Contest (the õContestö) substantially as described in these rules, and by participating, each participant agrees as follows:
